In essence, the Article alleges that our client, EIM, is implicated and involved in the Marc Dutroux Belgian paedophilia scandal. It does so through wrongly asserting that Arpad Busson, the Chairman of the children's charity, ARK (which funds a school in London) is also the Chairman of the European Institute of Management (thereafter referred to as 'EIM' within the Article). It refers to a website www.pehi.eu, which accuses the European Institute of Management as being connected with the paedophilia scandal.

In fact, the Article confuses the European Institute of Management with our client, EIM. The two are not in any way related. The allegations made within the Article are false, gravely defamatory and misleading.

The Article also constitutes a breach of our client's intellectual property rights. By publishing the Article, you are holding our client out as associated with the European Institute of Management. Publication of such false and misleading descriptions is likely to cause confusion or mistake or to deceive as to the affiliation, connection or association of our client with other financial entities and other entities allegedly linked to criminal acts. These infringements of our client's rights are serious.

As the host of the eutruth.org.uk website you are liable for the publication of the defamatory and infringing material. Once an internet service provider has notice that it is hosting or publishing a defamatory publication, it has no defence under Section 1 of the Defamation Act 1996.

Now that you are on notice of the defamatory material you are enabling to be published, our client requires the following action to be taken as a matter of urgency:

1. That you immediately and permanently delete the defamatory content from your server, and effect the removal of the article from the eutruth.org.uk website; and
2. Your undertaking in writing not to allow the same or similar allegations contained within the article to be held on your server.


In anticipation of your co-operation we await your confirmation via return e-mail to linda.koekemoer.co.uk that you have complied with the requests set out above.



Pending confirmation of the above we must reserve all of our client's rights, including his right to issue legal proceedings against you.

We trust this will not be necessary and look forward to your prompt response.
