NOTs PTS HANDLING REPAIR LIST

STEP 15 OF THE AUDITED NOTs
PROGRAM, NOTs PTS HANDLING

There are two main uses for this list:

- A. If after a session or a series of sessions on Step 15 of the Audited NOTs Program a pre-OT bogs, gets ill or runs into trouble.
- B. When the NOTs PTS Handling Technique is run through to step H and the PTS BT or cluster has not blown.

**USING THE LIST TO REPAIR STEP 15
OF THE AUDITED NOTs PROGRAM**

When using this list to repair a session or series of sessions on the Audited NOTs PTS Step, the list can be done with a prefix such as "On the NOTs PTS Step, _____?" to limit the pre-OT's attention to those sessions. It can also be assessed with no prefix at all.

Instructions are given on each question for handling the BPC or error. The instructions call for establishing ownership of charge on questions which could be reading on the pre-OT's charge as well as a BT or cluster. If there is no instruction to establish ownership, the auditor locates the BT or cluster that read on the question and handles per the instructions given for that question.

Note: Some of the questions call for running the NOTs PTS Handling Technique if the BT or cluster being handled is PTS, or the NOTs Valence Technique if not PTS. In such an instance, if the auditor does not know whether or not he is handling a PTS BT, he would check this on the meter ("Is this a PTS BT?") and handle accordingly.

As what is wrong could be wrong with more than one, each reading line is rechecked and if it reads again it is taken up again and handled to EP. Each line is rechecked until it is no longer reading before continuing on with the rest of the list. The list is always assessed Method 3.

**WHEN A BT DOES NOT BLOW ON NOTs
PTS HANDLING TECHNIQUE**

When the auditor is running the NOTs PTS Handling Technique and gets all the way through to step H and there is no blow, the auditor has the pre-OT place his attention on the BT or cluster being run and assesses this repair list. It is assessed Method 3, while keeping the pre-OT's attention on that exact BT or cluster.

The auditor would not recheck each reading question once handled, as the assessment is directed to a specific BT or cluster. Once that BT or cluster has blown, that is the EP of this repair list.

1. A BT OR CLUSTER WITH OUT-INT?

(Handle per procedure for handling out-Int on NED for OTs.)

2. WRONG PTS ITEM?

(Establish ownership of charge. Find out what the wrong PTS item is and indicate it. If no F/N, correct the wrong item. If the BT or cluster has not blown, carry on with steps B to H of the NOTs PTS Handling Technique.)

3. WRONG ITEM?

(Establish ownership of charge. Find out what the wrong item is and indicate it. If no F/N, correct the wrong item. On a wrong PTS item handle the BT or cluster with steps B to H of the NOTs PTS Handling Technique. If the wrong item was not from a PTS handling, handle to blow using the NOTs Valence Technique.)

4. AN ITEM THAT WAS CORRECT FOR ONE ACTED AS A WRONG ITEM FOR OTHERS?

(Indicate. If no relief, assess and handle an L4BRB.)

5. WAS IT A WRONG ITEM FOR EVERYONE?

(Indicate. If no relief, assess and handle an L4BRB.)

6. WAS THE PTS ITEM FOUND ONLY A RESTIMULATOR FOR THE ACTUAL SUPPRESSIVE?

(Complete the "Who or what are you PTS to?" list to get the actual suppressive, and carry on with steps B to H of the NOTs PTS Handling Technique.)

7. WAS IT REALLY SOMEONE ELSE THAT WAS PTS?

(Indicate to the BT or cluster that he was being erroneously audited on a PTS action. If no blow, handle with the NOTs Valence Technique.)

8. AUDITED OVER AN OUT-RUD?

(Establish ownership of charge. Handle the out-rud to F/N. If a BT or cluster's charge, handle with the PTS Handling Technique or NOTs Valence Technique if not PTS.)

9. ARC BREAK?

(Establish ownership of charge. Handle the ARC break to F/N. If a BT or cluster's charge, handle with the PTS Handling Technique or NOTs Valence Technique if not PTS.)

10. PRESENT TIME PROBLEM?

(Establish ownership of charge. Handle the PTP to F/N. If a BT or cluster's charge, handle with the PTS Handling Technique or NOTs Valence Technique if not PTS.)

11. HAS A WITHHOLD BEEN MISSED?

(Establish ownership of charge. Handle the M/W H to F/N. If a BT or cluster's charge, handle with the PTS Handling Technique or NOTs Valence Technique if not PTS.)

12. WAS THERE AN OVERT?

(Establish ownership of charge. Handle the overt to F/N. If a BT or cluster's charge, handle with the PTS Handling Technique or NOTs Valence Technique if not PTS.)

13. A BT OR CLUSTER WITH A WRONG PROBLEM?

(Locate the reading problem and indicate. Continue with steps D to H of the NOTs PTS Handling Technique.)

14. HAS AN AUDITOR MADE PROBLEMS FOR A BT OR CLUSTER?

(Handle with steps C to H of the NOTs PTS Handling Technique.)

15. HAS BAD AUDITING MADE A PROBLEM FOR A BT OR CLUSTER?

(Handle with steps C to H of the NOTs PTS Handling Technique.)

16. IT WASN'T THAT BT'S OR CLUSTER'S PROBLEM?

(Find out what happened and indicate the BPC. Handle according to what comes up - either complete the NOTs PTS Handling Technique or handle with the NOTs Valence Technique.)

17. DID NOT GET WHAT THE BT'S PROBLEM WAS?

(Locate the reading problem and indicate. Continue with steps D to H of the NOTs PTS Handling Technique.)

18. WAS THERE A BT OR CLUSTER WITH AN EARLIER-SIMILAR PROBLEM?

(Have the BT or cluster tell what the E S problem was and then carry on with steps D to H of the NOTs PTS Handling Technique.)

19. WAS THERE A BT OR CLUSTER WITH ANOTHER FLOW ON PROBLEMS THAT SHOULD HAVE BEEN RUN?

(Find out from the BT which flow should have been run, and run it to F/N. If needed the auditor can check on the meter:

"You created a problem for [item from A]?"

"[Item from A] created a problem for others?"

"You created a problem for yourself because of [item from A]?"

and run the reading flows in order of best read. If no blow, carry on with steps D to H of the NOTs PTS Handling Technique.)

20. BT OR CLUSTER RAN THE WRONG FLOW ON PROBLEMS?

(Find out from the BT which flow should have been run, and run it to F/N. If needed the auditor can check on the meter:

"You created a problem for [item from A]?"

"[Item from A] created a problem for others?"

"You created a problem for yourself because of [item from A]?"

and run the reading flow(s) in order of best read. If no blow, carry on with steps D to H of the NOTs PTS Handling Technique.)

21. A BT OR CLUSTER BEING A PROBLEM?

(Have the pre-OT ask the BT or cluster: "Who were you before that?" to a blow.)

22. A BT OR CLUSTER HOLDING A PROBLEM?

(Get what the problem is and then continue with steps D to H of the NOTs PTS Handling Technique.)

23. A BT OR CLUSTER WITH A WRONG ENVIRONMENT?

(Have the pre-OT ask "Where are you?" and get the BT or cluster to reach out to the environment. If no blow, handle with steps A to E of the NOTs PTS Handling Technique.)

24. A BT OR CLUSTER DISPLACED IN TIME?

(Have the pre-OT ask "Where are you?" and get the BT or cluster to reach out to the environment. If no blow, handle with steps A to E of the NOTs PTS Handling Technique.)

25. A BT OR CLUSTER WHO WAS RUN ON THE WRONG PRIOR CONFUSION?

(Locate the correct prior confusion and continue with steps E to H of the NOTs PTS Handling Technique.)

26. TOO WIDE AN ATTENTION SPAN?

(Indicate the BPC. Check to see if there is an incomplete BT and if so, handle by completing the incomplete action.)

27. AUDITED PAST A SESSION EP?

(Establish ownership of charge. Rehab the win. If it is a session EP audited past in the current session, end off once the BPC has been handled.)

28. AUDITED PAST A MAJOR WIN?

(Establish ownership of charge. Rehab the win. If it is a major win audited past in the current session, end off once the BPC has been handled.)

29. THE BT OR CLUSTER BEING RUN WAS NOT PTS IN THE FIRST PLACE?

(2WC to F/N. Blow the BT or cluster with the NOTs Valence Technique.)

30. WAS A BT LEFT THAT DIDN'T BLOW?

(Handle with the NOTs PTS Handling Technique if PTS, or the NOTs Valence Technique if not PTS.)

31. WAS IT ONLY A COPY OF SOMEONE ELSE'S PTS SITUATION?

(Have the pre-OT spot the fact that it was a copy. If no F/N, locate and handle the copying BT.)

32. A NUMBER OF BTs WERE PTS TO A COMMON SP?

(Indicate. If they don't all blow at once on indication, handle each one separately with the NOTs PTS Handling Technique.)

33. A BT OR CLUSTER PTS TO SOMEONE KNOWN ON THE BACKTRACK?

(Handle with steps A to H of the NOTs PTS Handling Technique.)

34. A BT PTS TO THE SAME SUPPRESSIVE OVER SEVERAL LIFETIMES?

(Handle with steps A to H of the NOTs PTS Handling Technique.)

35. PTS TO AN EVIL BT OR CLUSTER?

(Do the following on the evil BT or cluster until it blows:

- a. Run "What have you done?" "What have you withheld?" alternate repetitive, to F/N.
- b. L&N "What evil purpose have you had?"
- c. Blow the BT or cluster with the NOTs Valence Technique.

Handle the BT or cluster who went PTS to the evil BT or cluster with the PTS Handling Technique steps B to H.

36. A BT OR CLUSTER WITH A FALSE PTS CONDITION?

(2WC E/S to F/N. If not blown, handle the BT with the NOTs Valence Technique.)

37. A BT OR CLUSTER WITH A PRETENDED PTS CONDITION?

(2WC E/S to F/N. If not blown, handle the BT with the NOTs Valence Technique.)

38. A BT OR CLUSTER THOUGHT SOME INCIDENT OCCURRED WHICH DIDN'T?

(Have the pre-OT indicate this to the BT or cluster and then ask, "What problem did that false incident create for you?" Continue with steps D to H of the NOTs PTS Handling Technique.)

39. A BT OR CLUSTER WHO HAD A PRIOR CONFUSION WITH OTHER BEINGS?

(Have the pre-OT ask the BT or cluster, "What was the confusion?" and if no blow, "Who are you?")

40. A SINGULAR THETAN WAS IMPLANTED TO BELIEVE HE WAS A GROUP?

(Have the pre-OT ask the BT or cluster, "What was the confusion?" and if no blow, "Who are you?")

41. DOESN'T KNOW WHO HE IS?

(Have the pre-OT ask the BT or cluster, "What was the confusion?" and if no blow, "Who are you?")

42. BECAME A BODY PART?

(Have the pre-OT ask the BT or cluster, "What problem has [body part named] been to you?" and continue with steps D to H of the NOTs PTS Handling Technique.)

43. A BT THAT'S IN THE VALENCE OF SOMEONE AND IS RECEIVING THE PUNISHMENT INTENDED FOR THAT PERSON?

(Handle with steps A to H of the NOTs PTS Handling Technique.)

44. A BT MOCKED ITSELF UP AS A BODY PART AND TAKES THE PUNISHMENT INTENDED FOR THAT BODY PART?

(Handle with steps A to H of the NOTs PTS Handling Technique.)

45. SELF-SACRIFICE?

(Handle with steps A to H of the NOTs PTS Handling Technique.)

46. WAS A NOTs PTS HANDLING LEFT INCOMPLETE ON SOMEONE?

(Complete the incomplete action.)

47. A BT OR CLUSTER WITH A HIDDEN STANDARD?

(2WC E/S to F N. If no blow do steps A to H of the NOTs PTS Handling Technique.)

48. DID SOMEONE ELSE HAVE THIS PHYSICAL CONDITION?

(Find out from the pre-OT what the physical condition is and ask, "Who had that condition?" Then ask the pre-OT, "Is there a BT or cluster associated with or being [terminal named]?" and handle with steps C to H of the NOTs PTS Handling Technique. Repeat, "Is there a BT or cluster associated with or being [terminal named]?" until it no longer reads on checking.)

49. A BT OR CLUSTER THAT TRANSFERRED OVER FROM SOME OTHER PERSON'S SPACE?

(Handle with steps A to H of the NOTs PTS Handling Technique.)

50. A BT OR CLUSTER HAS AN AMBITION TO NOT HAVE A BODY?

(Handle with steps A to H of the NOTs PTS Handling Technique.)

51. A BT OR CLUSTER WHO DOESN'T THINK HE HAS ANY PROBLEMS AS HE'S GOT THEM ALL SOLVED?

(L&N on the BT or cluster, "Who made lots of problems?" Then continue with steps B to H of the NOTs PTS Handling Technique.)

52. ATTENTION FIXED ON OR DRAWN TO A REMOTE TERMINAL?

(Have the pre-OT locate where the terminal is in the physical universe and find a BT or mass that is at the location of that terminal. Handle with the PTS Handling Technique, steps A to H. Check on the meter for "any other BT or mass that is at [the location of that terminal]?" and handle as above, until it no longer reads when checked.)

53. ATTENTION FIXED ON OR DRAWN TO A REMOTE LOCATION?

(Have the pre-OT tell you what the location is and find a BT or mass that is at that location. Handle with the PTS Handling Technique, steps A to H. Check on the meter for "any other BT or mass that is at [that location]?" and handle as above, until it no longer reads when checked.)

54. NO MORE PTS BTs?

(Indicate. If no F/N VGIs, rehab the point when there were no more PTS BTs.)

55. IS THERE A PRESENT TIME PHYSICAL UNIVERSE PTS SITUATION?

(Establish ownership of charge. 2WC to F/N. Note for C/S.)

56. CONNECTED TO A SUPPRESSIVE IN THE PRESENT TIME ENVIRONMENT?

(Establish ownership of charge. 2WC to F/N. Note for C/S.)

57. IS THERE SOMETHING ELSE WRONG?

(Establish ownership of charge. 2WC to F/N and handle as indicated by what comes up.)
