## Officer Narrative

ON 09-27-2006 I MET WITH FAITH ALLEN , AND HER ATTORNEY DIANE M. STERNLIEB AT 1390 BINFORD PL IN BROOKFIELD VILLAGE.

DIANF(ATTORNEY), AND FAITH (MOTHER) TOLD ME MINOR CHILD MASHA ELIZABETH ALLEN WAS AT THE RESIDENCE OF AMANDA SLATEN FAITH ALLEN (MOTHER) SAID THE MINOR CHILD WAS LEFT AT THE SLATEN RESIDENCE BY ATTORNEY'S THAT DID NOT HAVE PARENTAL PERMISSION TO DO SO. MASHA HAD BEEN AT THE SLATEN RESIDENCE FOR 1 WEEK.

FAITH ALLEN CAME TO THE RESIDENCE TO TAKE CUSTODY OF HER LEGAL ADOPTIVE DAUGHTER (MASHA ALLEN AGE 14). AMANDA SLATEN REFUSED TO RETURN THE CHILD TO FAITH. AMANDA CALLED THE SHERIFF'S OFFICE FOR ASSISTANCE. AMANDA'S RELATIONSHIP WAS FRIEND TO FAITH ALLEN.

DIANE STERNLIEB TOLD ME THIS WAS A HIGH PROFILE CASE INVOLVING CONGRESS, AND THE CASE HAD BEEN ALL OVER THE NEWS. ETC. DIANE SAID THE SLATENS HAD NO LEGAL RIGHT TO KEEP MASHA ALLEN IN THEIR HOME. I TOLD DIANE I COULD NOT GO IN THE HOUSE AND DRAG HER OUT AGAINST HER WILL. DIANE AKED ME "WHY NOT?"

I I OLD HER WE DID NOT PLACE KIDS.

I CALLED THE DEPARTMENT OF FAMILY AND CHILDREN SERVICE. I SPOKE WITH TINA SHEAR REGARDING THIS INCIDENT, TINA ALSO SPOKE TO THE ATTORNEY DIANE STERNLIEB.

TINA SAID SHE WAS GOING TO COME TO THE RESIDENCE ON BINFORD.

A SHORT TIME LATER TINA (DFACS) CALLED ME BACK, TINA TOLD ME SHE WAS NOT COMING TO BINFORD PLACE. TINA

SAID SHE SPOKE WITH HER SUPERVISOR, AND THE SUPERVISOR TOLD HER THIS WAS A CUSTODY ISSUE. TINA TOLD ME IF THE ADOPTIVE MOTHER HAD LEGAL PAPERS CONFIRMING SHE WAS THE CUSTODIAL PARENT THE CHILD WOULD HAVE TO GO WITH THE MOTHER (FAITH ALLEN).

AS LEXPLAINED THIS TO AMANDA SLATEN, MASHA ALLEN LEFT ON HER OWN FREE WILL GOING WITH THE MOTHER.

I ATTACHED COPIES OF THE CERTIFICATE OF ADOPTION, AND CERTIFICATION OF BIRTH PROVIDED BY FAITH ALLEN WITH THIS REPORT.

AFTER LEAVING THE SLATEN HOME ON BINFORD AMANDA SLATEN CALLED ME VIA PHONE. AMANDA TOLD ME MASHA TOLD HER MINOR DAUGHTER SHE WAS GOING TO GO WITH HER MOTHER, ACT AS IF EVERYTHING WAS O.K. THEN KILL HERSELF.

I EXPLAINED TO AMANDA I HAD NO PRIOR KNOWLEDGE OF THIS INFORMATION AND COULD NOT CHANGE WHAT HAD BEEN DONE.

I CALLED TINA SHEAR BACK WITH THIS INFORMATION, AND SHE SAID AMANDA NEEDED TO CALL HER OFFICE IN THE MORNING TO MAKE A REFERRAL.

A SHORT TIME LATER I RECEIVED A PHONE CALL FROM JAMES MARSH, JAMES MARSH TOLD ME HE WAS AN ATTORNEY, THEN ASKED ME IF I WAS FAMILIAR WITH THE MASHA ALLEN CASE. I TOLD HIM I WAS NOT. JAMES MARSH BEGAN TELLING ME MASHA ALLEN WAS BORN IN RUSSIA. MASHA WAS STABBED IN THE NECK BY HER BIOLOGICAL MOTHER. MASHA WAS PLACED IN AN ORPHANAGE IN RUSSIA. A MAN NAMED MATTHEW MANCUSO ADOPTED HER, SEXUALLY ABUSED HER. MADE CHILD PORN PHOTOS, THEN PLACED HER ALL OVER THE INTERNET.

JAMES TOLD ME HE WAS IN WASHINGTON D. C. TODAY REGARDING THIS CASE. JAMES SAID MASHA WAS ENDANGER WITH THE MOTHER, AND BELIEVED THERE NEEDED TO BE FURTHER ACTION.

I EXPLAINED TO JAMES I HAD NO AUTHORITY TO CHANGE WHAT HAD BEEN DONE, AND I HAD NO PRIOR KNOWLEDGE OF THIS CASE. MASHA LEFT ON HER OWN FREE WHILE I WAS EXPLAINING TO AMANDA SLATEN SHE HAD NO LEGAL CUSTODY.

I TOLD HIM TO CONTACT SGT. KEN HARPER IF HE WANTED FURTHER ACTION.

JAMES DID CONTACT SGT, HARPER.

SGT. HARPER TOLD ME TO GO LOCATE THE CHILD AT 8261 COLQUITT STREET, AND TAKE MASHA ALLEN INTO CUSTODY.

I WENT TO 8261 COLQUITT STREET. I TOOK MASHA ALLEN INTO CUSTODY, I TRANSPORTED HER TO DOUGLAS GENERAL WELLSTAR HOSPITAL FOR A MEDICAL EVALUATION. SGT. HARPER ASSISTED ME WITH THIS INCIDENT.

DOUGLAS WELLSTAR TOOK MASHA INTO THEIR CARE, AND DID A 10-13 FOR FURTHER MEDICAL TREATMENT.
